1) INTRODUCTION

This privacy notice provides you with details of how we collect and process your personal data through the following registration form and for the purposes you fill in such a registration form. It applies on the following FIRST® LEGO® League Virtual Open International Greece 2021 Registration Form: https://docs.google.com/forms/d/e/1FAIpQLSc98eeKA3eX-qfsmE7mu8IYXabxhqjilg18oS_Fc-pO9EruVA/viewform.

eduACT Non-Profit Association is the data controller and we are responsible for your personal data.

2) DATA WE COLLECT ABOUT YOU

Personal data means any information capable of identifying an individual. It does not include anonymized data.

We process the following categories of personal data that you provide in on our Volunteer Registration Form:

- A) Your personal data, as the adequate coach that fills in the form, on behalf of the team you represent:
 - Your name, email address and mobile number. We need that information in order to communicate with you for the purposes of the FLL event.
 - Your communication data (name, email, mobile number) so that we can inform you on future events that might interest you.

Please note that as a coach you will be asked to register and connect to FIRST Remote Event Hub by LEGO Education and the LEGO Foundation, where you will find the program of the event and the links to connect to.

B) Team members' personal data:

Name, surname, date of birth, parents' names, address, parent's telephone number, parent's Email of each member of the team in order to organize the event.

Note to the coach:

Please note that: you must not provide us with any of your team members' data, unless you have previously collected their parent's application to take part in the FLL International Open. You should upload parents' applications in the **appropriate field**.

C) Connection data: The FLL International Open will be held virtually through the Zoom platform. Every team must connect to the event link through a stable internet connection. There is no need to create a Zoom account to participate, but Zoom must collect some communication data (e.g., IP address, approximate location, browser type, type of terminal equipment, Operating System) of the owner of the terminal equipment (e.g., desktop, tablet, smartphone etc.), required for the establishment and the realization of the communication. Those information are encrypted to ensure their safety and confidentiality. You can find more info on Zoom's privacy policy here. You may be asked to consent to Zoom's processing before connecting to the event if you never previously used the Platform.

Sensitive Data

We do not collect any Sensitive Data about you. Sensitive data (special categories) refers to data that includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health and genetic and biometric data. You should not provide us with any of the above type of data. If by any chance you provide us with any kind of sensitive data, we will immediately delete it.

3) WHY IS OUR PROCESSING LEGAL

Our lawful ground for the collection and for the above processing is the performance of a contract of participating in the FLL Open and/or taking steps at your request to enter into such a contract with us. If you don't provide us with the requested data, we will not be able to enter into such a contract with you, as they are necessary for its performance.

Our lawful ground for the storage of your communication data is our legitimate interest to include you in our newsletter list so that we can inform you on future events that might interest you. You are entitled to object to the retention of your communication data by filling in the **appropriate form field** or by unsubscribing from our newsletter by clicking the button "unsubscribe" that you can find on the bottom of each email you 'll receive from us.

4) USES OF YOUR DATA

We will only use your personal data for the purpose it was collected for or a reasonably compatible purpose if necessary. In case we need to use your details for an unrelated new purpose we will let you know and explain the legal grounds for processing or request for your consent if necessary.

We do not carry out automated decision making or any type of automated profiling.

5) PHOTO AND VIDEO IMAGES

Before you apply to participate in the FLL International Open, you must be aware that the event is a public event and usually attracts the interest of the press and media (TV, radio, video recording, photo shooting, etc.). The whole event will be recorded so that eduACT can create screenshots and short videos that will be published. Those videos and photos will not include recognizable images of the participants (e.g., blurred photos, photos taken from the back of people etc.). Photos or videos of you or your children, may be recorded during those events, and published in newspapers or magazines, or transmitted through TV Channels, or social media (e.g. Facebook, Flickr, You Tube), or web pages of eduACT, LEGO Group and other affiliated companies but only if the following conditions apply:

Any processing of photos or video footage that takes place on our behalf, may be published, if the images are distant, or do not reflect participants' faces, or have been previously processed appropriately for anonymization (e.g. blurring). Any processing of photos or video footage that takes place on our behalf is regulated by data processing contracts with every third party (e.g., photographers, service providers etc.) that provides us any relevant services.

We process this type of data, for our legitimate interest to promote our non-profit work, events and activity.

You are entitled to object to the collection/storing/publication of your or your child's images (photo or/and video footage), on grounds relating to your particular situation, at any time, but you should be aware that your objection may be satisfied only by excluding you of any activities that involve photo shooting or video recording.

If you wish to object, please fill in the appropriate form field.

If you don't fill it in and decide on a later time that you wish to object, it may require that you notify us on your objection within a due timeframe before the processing, so that we can make appropriate arrangements to exclude you from the processing.

6) DISCLOSURES OF YOUR PERSONAL DATA

We give access to some of your personal data (name and/or communication details and/or photo images), only to our partners and only if it is necessary in order to provide us their services, or because there is a legal or contractual requirement). Those parties are set out below:

- Service providers who provide IT and system administration services.
- Professional advisers including lawyers, auditors and insurers
- Government bodies that require us to report processing activities.
- Companies who provide us with event organization services
- Other parents, children and others, participating in the activities or events.

We require all third parties to whom we transfer your data to respect the security of your personal data and to treat it in accordance with the law. We only allow such third parties to process your personal data for specified purposes and in accordance with our instructions and the binding contract they sign.

7) INTERNATIONAL TRANSFERS

We are subject to the provisions of the General Data Protection Regulations that protect your personal data. We use some providers that are located outside the EEA, for example we use the service Google G-Suite, that provides us with multiple cloud services. Where we transfer your data to third parties outside of the EEA, we will ensure that certain safeguards are in place to ensure an equivalent degree of protection for your personal data as the one that the GDPR provides. As such we may use Standard Contractual Clauses approved by the Commission, along with additional technical and organizational measures (e.g., encryption, pseudonymization), or codes of conduct or certification mechanisms approved by the European Commission which give personal data the same protection it has in Europe. If none of the above safeguards is available, we may request your explicit consent to the specific transfer. You will have the right to withdraw this consent at any time.

8) DATA SECURITY

We have put in place security measures to prevent your personal data from being accidentally lost, used, altered, disclosed, or accessed without authorization. We also allow access to your personal data only to those employees and partners who have a business need to know such data. They will only process your personal data on our instructions, and they must keep it confidential.

9) DATA RETENTION

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

We will retain your communication data for 2 years after the ending of your last participation in our

events, so that we can inform you on future events you might be interested in. We will retain the rest of your data for maximum 1 year from your participation.

10) YOUR LEGAL RIGHTS

Under data protection laws you have rights in relation to your personal data that include:

- the right to request access to your data,
- the right to request correction of your data,
- the right to request erasure of your data,
- the right to request restriction of the processing,
- the right to request to object to the processing, (where we process it on the basis of our legitimate interests)
- the right to request to portability of any data processed by automated means and
- (where the lawful ground of processing is consent) the right to request to withdraw consent.

If you wish to exercise any of the rights set out above, please email us at info@eduact.org. We may need to verify your identity by means of formal identification documents before replying to your request.

If you are not happy with any aspect of how we collect and use your data, you have the right to complain to the Hellenic Data Protection Authority, www.dpa.gr). We should be grateful if you would contact us first if you do have a complaint so that we can try to resolve it for you.
